APE-INV final conference:



Télécom ParisTech (Amphi Émeraude) - Paris, 3-4 September 2013

Over the past decade, universities and public research organizations have devoted increasing attention to the issue of Intellectual Property (IP), as part of a general drive towards greater efforts to collaborate with industry, commercialise their research results, and foster science-based entrepreneurship. APE-INV, the Research Networking Programme on Academic Patenting in Europe, sponsored by the European Science Foundation, has promoted active research in the field starting in late 2009 (http://www.academicpatenting.eu). It has coordinated the collection of micro data on inventors, scientists, and patents and promoted the production of country-based studies throughout Europe. APE-INV has also promoted a working definition of "academic patent", centered upon the identity of the inventor (the academic researcher) rather than that of the assignee (the researcher's university). The largest part of academic patents turn out to be assigned to business companies, either as a result of research sponsorship or of market transactions. APE-INV has also actively promoted a debate on the economic value of academic patents, the role of IP legal norms and university autonomy in determining universities' propensity to invest in patents, or the relationship between scientists' productivity and their patent-related activities. Several papers will be published in a special issue of *Industry & Innovation*, to be published in Fall 2013.

The APE-INV final conference will bring together the contributors to the special issue and other scholars for a meeting with IP managers and stakeholders, either in university, public research organizations, or policy bodies. The results obtained by APE-INV will be discussed in the light of fieldwork experience, with the objective of setting the future research agenda. Non-technical, policy-oriented presentations by research scholars will be followed by open discussion. In turn, fieldwork's experience will be discussed in the light of the quantitative evidence produced by the project.
